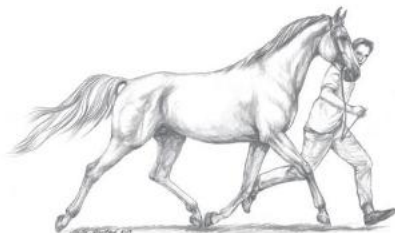
### XXXIV. National horse show of Shagya arab breed with International Participation

### **Conditions of Participation:**

Only **Shagya Arabian horses** registered in studbooks recognized by the ISG can participate in the show.

### **Categories and Age Classes:**

1. 1-year-old stallions (born 2025)
2. 2-year-old stallions (born 2024)
3. 3-year-old stallions (born 2023)
4. 4-6 year-old stallions (born 2020-2022) - CHAMPIONSHIP young stallion, categories 1, 2, 3, 4
5. 1-year-old mares (born 2025)
6. 2-year-old mares (born 2024)
7. 3-year-old mares (born 2023)
8. 4-6 year-old mares (born 2020-2022) - CHAMPIONSHIP young mare, categories 5, 6, 7, 8
9. 7-10 year-old stallions (born 2016-2019)
10. 11-year-old and older stallions (born 2015 and earlier) - CHAMPIONSHIP older stallions, categories 9, 10
11. 7-10-year-old mares (born 2016-2019)
12. 11-year-old older mares (born 2015 and earlier) - CHAMPIONSHIP older mares, categories 11, 12

(The organizer reserves the right to combine categories, for example, in the event of a low number of horses entered)

### **Presentation Area:**

- A triangle set up on a prepared sand surface.

### **Evaluation System:**

Horses will be evaluated by a three-member judging committee, and each judge assigns individual scores. The final score will be the average of all ratings and determines the ranking of the horse within its category.

The following criteria will be judged:

- Type
- Head
- Neck
- Body conformation
- Legs
- Walk
- Trot

Scoring will be on a 1–10 point scale (whole numbers only):

- 10 – Excellent
- 9 – Very good
- 8 – Good
- 7 – Satisfactory
- 6 – Adequate
- 5 – Sufficient
- 4 – Insufficient
- 3 – Poor
- 2 – Very poor
- 1 – Unacceptable

## **Championships and Awards:**

The top two horses in each category advance to the overall championship.

- **Young stallion winner** (1st and 2nd place from categories 1, 2, 3, 4 will participate)-they will go immediately after group 4
- **Young mare winner** (1st and 2nd place from categories 5, 6, 7, 8 will participate) - they will go immediately after group 8
- **Older stallion winner** (1st and 2nd place from categories 9, 10 will participate) - they will go immediately after group 10
- **Older mare winner** (1st and 2nd place from categories 11, 12 will participate) - they will go immediately after group 12

The winners of each championship will be selected and will advance to the final championship for the champion and reserve champion of the show. The organizer will award each participant of the show in each category with a ribbon.

## **Rules for the show:**

- Members of the organizing committee, judges, exhibitors, performers and persons accompanying them must unconditionally comply with the organizing regulations.

## **Judges and Organizer:**

- No member of the organizing committee may judge. Also, no elected judge may show, ride or otherwise handle an entered horse or act as a steward, technical delegate or announcer.
- The organizing committee reserves the right to reject entries, but must justify the rejection. The organizers are personally responsible for compliance with the rules.

### Judges and exhibitors:

- Judges must be of integrity and make decisions honestly.
- Judges must not knowingly evaluate a horse that could cause a real or apparent conflict of interest.
- On the showground, any communication between the judge and the performer or between the holder and the breeder carried out through the organizer or steward.

### Veterinary and Medical Services:

A veterinarian and medical professional will be present and available throughout the entire event. Any related costs are the responsibility of the participant.

- **Veterinarians:** MVDr. Věra Hánová (+420 607 841 511)
- **Medical Service:** Medical services will be provided, if necessary, through the emergency room at the Příbram Hospital. A medical professional will not be directly present at the event location.

### Veterinary conditions and acceptance of horses, movement of horses in the area:

- Horses must be healthy and free of infectious diseases.
- Each horse must be presented with a horse certificate upon acceptance, stating that the horse has been vaccinated according to the vaccination schedule set by the manufacturer of the relevant vaccine and is immune to **influenza** (equine flu). The last vaccination must be carried out no later than 7 days before the show. The certificate must state the date of the last vaccination, including the operation number and name of the relevant vaccine.
- **Horses over 12 months of age** must be laboratory tested with a negative result for **infectious anemia**; the test **must not be older than 12 months. The result of the test is recorded by the veterinarian in the horse certificate, including the protocol number.**
- **Horses originating from EU member** states must be accompanied by a veterinary certificate (**TRACES**) issued by the competent authority of the member state.
- **Horses originating from third countries** must be accompanied by a valid CHED (Common Health Entry Document) and a copy of the relevant veterinary certificate.
- The certificate check must be carried out before the horse is unloaded. Without a valid vaccination certificate, the horse will not be allowed to be unloaded.
- The above veterinary conditions may be changed at any time for disease reasons.
- Veterinary inspection and horse loading: **Friday 31<sup>st</sup> July 2026: 12:00 - 20:00**  
**Saturday 1<sup>st</sup> August 2026: 7:00 - 9:00**
- The organizer reserves the right to adjust the veterinary conditions according to the current disease situation. In the event of any changes, we will inform you in a timely manner via the website or by e-mail.
- Exhibited horses must not come into contact with horses permanently stabled on the premises. Exhibitors are not allowed to move freely around the area with their horses, but only in areas designated for this purpose.

### Registration, stalls (stabling) and other fees:

- **The price for stall housing is 1,500 CZK/day/horse** (payment at the same time as the horse's registration).
- Horse movement will only be possible in designated areas. Building pens and fences is not allowed in the entire area.
- Hay and bedding are included in the stall price. However, each participant must provide their own water bucket for each horse (there are no waterers in the stalls).
- Everyone is responsible for cleaning the stalls themselves, and it is necessary to bring their own tools (fork, shovel and wheelbarrow), as the organizer does not provide them for loan.
- It is also necessary to immediately clean up excrement from their horses moving outside the stable throughout the area.
- **Starting fee for horses:**
  - horses of **members of the Shagya Arabian Breeders' Association in the Czech Republic, z.s.** pay 500 CZK /start/horse for participation.
  - **foreign horses and horses of non-members** of the Shagya Arabian Breeders' Association in the Czech Republic, z.s. pay the starting fee of **800 CZK /start/horse.**
- Additional applications will not be accepted.
- Send applications exclusively on **the attached form** (application page 1 and 2) **together with a copy of the horse's pedigree/passport and a copy of the vaccination certificate.**

- **The signed application** must be **sent and paid** by the end of the deadline, no later than **June 10, 2026** to the e-mail [shagyaarab.org@seznam.cz](mailto:shagyaarab.org@seznam.cz) or to the address Michaela Nosková, Trněný Újezd 2, 273 28 Zákolany, CZECH REPUBLIC. When sending an application by e-mail, wait for an e-mail confirming receipt of your application. If the confirmation e-mail does not arrive, it is possible that the application was not delivered, so please repeat the application. Payment must be made at the same time as submitting the application. Additional applications will not be accepted.
- **Account number 130 134 6309 / 0800, IBAN: CZ70 0800 0000 0013 0134 6309, Bank code (BIC): GIBACZPX** variable symbol (VS) please include your phone number, **the name of the horse and owner must be filled in the note for the recipient in order to identify the payment**. Cash payment on site is not possible. If the payment for the entered horse is not credited to the account of the Shagya Araba Breeders' Association in the Czech Republic, z.s. by 10<sup>th</sup> June 2026, the application will not be accepted.
- **Electrical connection: 700 CZK / day** (payment at the same time as the horse's application)
- **All entry fees are non-refundable.**

#### Horse Show:

- Unruly horses may be removed from the show area by the decision of the committee, without evaluation.
- Only one showman may be present with the horse in the show area.
- Judges may ask the showman to open the horse's mouth or lift a hoof for inspection.
- The judge must evaluate the horse being shown in stance, walk and trot. Horses that arrive late to the show area and thus do not participate in the joint show of the entire class will be excluded.
- Stallions aged 2 years and over must be shown with a safe and comfortable bridle on the bit. All show halters must be equally safe and comfortable for the horse. Sharp bridle is not permitted.
- Each horse will be assigned a starting number, which the showman will have attached to both his left and right arms.
- A horse that breaks free in the practice area will automatically be placed at the end of its class.
- If a horse leaves the practice area, it will be disqualified and eliminated.
- **All horses must arrive at the preparation area of the practice area no later than 15 minutes before the start of their class.**

#### Dress code:

- Exhibitors should be dressed in uniform white clothing (white trousers and a white shirt or T-shirt are recommended) including shoes and no headgear. Exhibitors who are inappropriately dressed will not be allowed into the showground.
- Advertising logos and inscriptions on clothing are not permitted. Clothing must also not contain any elements referring to the identity of the horse, owner or country of origin.

#### Unauthorized manipulations with horses:

- Changing the original color of the skin, coat or hooves is not permitted. Hooves may not be dyed and only colorless hoof oil is permitted. Mane dyes, glitter sprays and cosmetic treatments, as well as skin transplants are not permitted.
- Masking and painting the eyes, excessive excitement of the horse, or other unauthorized methods of presentation are prohibited. Burns, scars or other marks on the body of the exhibited horse, which, based on their location, indicate the use of unauthorized methods and may be considered as a substantial reason for excluding the horse from the show.
- Horses may be completely or partially clipped, with the exception of eyelashes and hair, hair inside the ears, whiskers around the nostrils, muzzle and eyes.
- The use of tools that serve to change the natural appearance of the horse, cause pain and discomfort to the horse is not permitted throughout the area. Exhibitors who use the items will be excluded from the event by the DC.

#### Animal protection (horse welfare):

- Excessive use of whips, excessive stimulation by sounds or intimidation, use of electric shocks, or painful effects of any kind are prohibited throughout the area and stable.
- All conditions regarding horse welfare will be strictly controlled.

### Drug Abuse:

- The intentional or accidental administration of any substance (including ginger, spices or similar irritants) that cannot be classified as normal food and that affects the performance, temperament or correctness of the horse's gaits is prohibited.
- The DC may order tests for unauthorized medication on any horse. Exhibited horses may be withdrawn by the DC or the owner based on a positive test. A horse that is withdrawn in this way cannot receive any title or award and cannot continue to participate in the relevant competition.
- The judges may request the organizers to test any horse.

### Accommodation, Catering, and Parking:

- Horse trailers and motorhomes must be parked in designated areas, where it will be possible to connect to an **electrical outlet for a fee of 700 CZK / day**, which must be paid in advance together with the horse registration.

### General provisions, rules and complaints:

- The organizer is not responsible for any damage to the health of horses, people or during transport.
- All participants must follow the rules and decisions of the judges.
- Horse performances must be in accordance with the ISG rules.
- **By submitting an application, the participant agrees to the publication of his/her personal data and the data of the entered horse/horses in the exhibition catalogue, the results catalogue, publication on the tables placed on the horse's box, in commenting, media processing including live broadcast on EquiTV, photography and other promotional materials related to the event including publication on the website of the Shagya Arabian Breeders' Association in the Czech Republic, z.s.**
- Furthermore, the organizer reserves the right to move the event to another date, adjust its course or cancel it completely in the event of unforeseen circumstances, force majeure or serious danger.
- The organizer reserves the right to merge, divide or cancel individual classes. The participation fee and the stabling fee are non-refundable.
- Starting numbers will be issued by the organizer upon registration of the horse/horses.
- After the end of the event, starting numbers must be returned and the horse's license will be issued back.
- All horses – **INCLUDING ALL FOALS** – must be presented on hand (free movement of foals throughout the area is not possible).
- Only participants of the show can file a complaint against an alleged violation of the rules. Such a protest must be filed in writing within 1 hour of the alleged violation of the DC rules. **Non-refundable fee of CZK 2,500.**
